**DECLARATION:**

I, the undersigned in consideration of and as a condition of acceptance of my application for entry in the event for myself, heirs, executors and administrators hereby release and waive all claims, rights or causes of action which I might otherwise have from or arising out of my entry or participation in the said event including any losses or damages I might suffer whatsoever.

This waiver, release and discharge shall be and operate separately in favour of all persons, corporations and bodies involved or otherwise participating in promoting, staging, supervising or supporting the event and their servants, agents, representatives and officers or any of them including medical and paramedical practitioners and personnel, police officers and shall so operate whether or not any loss, injury or damage is attributable to the act, omission or neglect of any one or more of them.

**I/we** understand due to disease such as equine influenza the **NSW DPI** other state and commonwealth bodies may restrict or prevent movement of horses/vehicles/persons for a period of time ("**standstill**"). I acknowledge and agree that a standstill is a risk of attending the event which I accept and **I/we** agree to pay all cost/expenses incurred relating to myself and my horses arising from any standstill.

**I/we** .....further acknowledge that **I/we** release Sandy Hollow Charity Horse Ride Committee, the event organisers and Westpac Rescue Helicopter Service from any liability or responsibility for any cost, losses or other damages arising in any way from any lockdown or for a period of time standstill occurring during or following any event.**I/we** agree to provide all that is required for myself and my horse for and during the event.
